# OASIS-C2 Accuracy

OASIS-C2 Accuracy is an intermediate level, two-day workshop designed to provide home health field clinicians, QA reviewers, educators, and managers with the knowledge and information necessary to accurately apply CMS guidance in the completion of critical OASIS-C2 items. This interactive workshop will examine the impact of OASIS-C2 accuracy related to the following vital areas: HHRG assignment/reimbursement, quality outcome/process measures, and the Home Health Star Rating system, including risk adjustment. New measures mandated by the IMPACT Act (Worsening of Pressure Ulcers and Drug Regimen Review with Follow-up) and the OASIS-C2 items related to these measures will be discussed in depth. Attendees will have the opportunity to test their OASIS-C2 knowledge and assessment skills and apply current guidance in patient scenarios using a variety of assessment strategies.

## Objectives

- Identify purposes, use and rationale for revision of OASIS-C2 data set used by Medicare home health agencies
- Identify core documents and regulatory requirements that provide basis for compliant and accurate use of OASIS-C2
- Describe relationship of OASIS-C2 to home health agency reimbursement, risk adjustment of quality measures and the CMS Home Health Quality Reporting Program (HHQRP), including Home Health Compare, Home Health Star Rating system, and Value Based Purchasing
- Define CMS criteria for accurate assessment and completion of OASIS-C2 items critical to reimbursement and quality reporting, to include use of the guidance manual, current Q&As, and selected strategies and tools to improve accuracy and avoid errors
