### 2019 Pennsylvania Home Care And Hospice Compensation Survey

#### GENERAL INSTRUCTIONS

Welcome to the 2019 Pennsylvania Home Care and Hospice Compensation Survey, produced by Gallagher Surveys in cooperation with The Pennsylvania Homecare Association, The Hospital Association of Pennsylvania and The Society of Healthcare Human Resources Associates of Pennsylvania. Below is information about survey organization and content, as well as general instructions for completion.

In response to feedback from various healthcare organizations throughout the state, the traditional Pennsylvania hospital survey has been expanded to now contain sections for Home Health, Private Duty/Non-Medical and Hospice positions. These three sections are co-sponsored by The Pennsylvania Homecare Association and home care/hospice/private duty agencies from across the state will also be submitting data for those sections. These participants will received results that contain data from both hospital-owned and independent agencies from across the state. Beyond this valuable home care/hospice/private duty data, participants will also have the option to purchase the hospital related section of the survey for an additional fee.

Survey participation process consists of just three steps:

- ♦ Submit Organizational and Compensation Policy on a preformatted spreadsheet.
- Populate the supplied template with your organization's compensation data
- ♦ Transmit your data to Gallagher Surveys via email

The survey results are based on individual incumbent data. This type of submission reduces the number of errors, increases the reliability of the final results, and allows for more extensive analysis of the data. We are very flexible regarding to the format of electronic salary submissions and can accept almost any electronic format as long as it contains the necessary data.

#### Instructions for Participating in the 2019 PA Home Care and Hospice Survey Compensation Survey

#### Step 1 Complete the Institution Data and Policy sections of the questionnaire

All of the Organizational and Compensation Policy data in the survey is **collected on a pre-formatted spreadsheet**. To begin, open the file "2019 PAHCH.xls" in MS Excel. Once opened, save a copy to your own computer to act as a working copy. **This spreadsheet file contains several worksheets:** 

- 1. Org Data
- 2. Policy
- **3.** Home Care Template
- 4. Hospice Template
- 5. Private Duty/Non-medical
- 6. Positions

Complete the "Org Data" and "Policy" worksheets of the spreadsheet (the first two). Once completed, this data can either be sent to Gallagher along with your compensation data (if you are including it within the spreadsheet) or separately (if you are submitting your compensation data on your own form).

### Step 2

#### Submit Individual Incumbent Salary Data

The survey will be compiled using individual incumbent data, i.e. a salary for each employee. The survey results will present two sets of statistics, one based on the individual incumbent data and another based on averages by organization (the "traditional method"). In order to compile the survey this way, all participants must submit an electronic report based on the provided template. Please note that we are flexible and can accept incumbent salary submissions in various formats as long as they contain the necessary data. Your submission does not have to match the template exactly, just provide the relevant data in some form.

Please submit home care data on the "Home Health Template", hospice data on the "Hospice" template and private duty/non-medical data on the "Private Duty" template. If your organization has more than one home care or hospice agency, you may copy the sheet and submit for each one.

As stated earlier, your actual submission does not have to match this format exactly as long as we receive all of the data in some electronic form.

Please submit FULL-TIME ANNUAL SALARIES for exempt positions and HOURLY RATES for non-exempt positions (full time and part time employees).

Shift Differentials	Report shift differentials as either a % or \$. Please note that we are now asking for Weekend Day, Weekend Evening and Weekend Night differentials. Please report the <b>total</b> <b>amount</b> for each differential.	
Per Visit Rate	The \$ amount paid per visit.
